



Fall Fun at Rader Farms

Come join us for a night of family fun at Rader Family Farms before they open to the public for the season! This event will take place on **Wednesday, September 5th from 4:30 – 7 PM**. Rader Family Farms has many activities for you and your family to enjoy at your own pace.

Play on the Straw Castle, climb up the Tire Tower, sift through the Corny Bins, meet the animals in the Barnyard, try out your throwing skills in the Barnyard Ball throw, and play in the toddler's Little Village house. The corn maze, pumpkin/apple slingshots, and apple blasters are available for additional fees (payable directly to Rader Farms at the event). The last entry into the maze is at 5:00pm. **Some attractions may be closed depending on the weather.**

A donut snack and bottled water will be provided to all (paid) attendees. Additional food (<https://www.raderfamilyfarms.com/food/>) will be available for purchase at Rader Farms (cash or credit card only). **No outside food may be brought in.**

Regardless of age, everyone must purchase a ticket to attend. Children under age 3 are free; however, they will not receive a donut or bottled water unless you choose one of the paid options below. An employee SFEA member may bring any or all dependent family members (listed on their membership) at the member price OR one guest at the member price. **Violation of the membership privileges (signing up those NOT on your membership) could lead to your SFEA membership being revoked. No children under 16 will be admitted unless supervised by a parent or guardian over 18 years of age.** This event is limited to 750 participants. If the demand exceeds available capacity, a drawing will be conducted. If you are enrolling with friends and wish to be considered as one enrollment, staple all enrollment forms together and mail in one envelope.

Enrollment closes on Thursday, August 23rd. All enrollment forms must be received in the Corporate South Activities Office, K-1 by 1 PM on the close date. Please make checks payable to SFEA. The Activities Office is not responsible for cash sent through the mail or late delivery of mail. All forms with payment can be dropped off in the secured mail slot of the Activities Office on K-1 at Corporate South (located in the hallway) or sent through the mail.

Please contact the Activities Office if you need to cancel your enrollment. If there is a waiting list and your ticket is resold, your money will be reimbursed. **If there is not a waiting list, your money will not be reimbursed.** In order to maintain records and a degree of fairness, do not sell your ticket to co-workers. The Activities Staff will handle all transactions.
