

# Women's 2010 Softball League

It's time to enroll in the Women's Softball League. Whether you are an avid softball player, or just out for the exercise, there is a team that will fit your skill level. So join the fun and get ready to take the field!

All SFEA members (including non-employee spouses and dependents out of high school) are eligible to participate in this league. Teams must consist of at least 10 full time players. Players can only enroll with one team.

**Divisions include:** Recreational, Intermediate, & Competitive

If there is not enough interest to warrant three divisions, the divisions offered will be recreational and competitive. Please list a second preference in the event only two divisions are offered.

Sub Pool! If you are interested in playing but cannot commit to a team, this sub pool is for you. For the \$5 sub fee, you can have your name put on a call list in the event a team is going to be short players for an evening. The sub list will be made available to the captains in each division. You can't be in the sub pool if you are already a dedicated sub for a team.

The league runs from May - August. All games will be played at State Farm Park. The league is governed by ASA Softball Slow Pitch rules. (Interdivision games are planned for Tuesdays and Wednesdays at 5:30 p.m. & 6:30 p.m.)

\*Rainout games will be held on Mondays at 5:30 p.m. & 6:30 p.m.\*

**Enrollment closes on March 11 ([add close date to my calendar](#)).** The enrollment fee is \$11 per full-time player (a minimum of 10 full-time players are required) and \$5 per substitute player. Players may sign up as subs, but will not be eligible for awards. Members who wish to play but are not associated with a team, are encouraged to sign-up as individuals. Each individual participant will be assigned to an existing team with an open roster or combined to form a new team.
