

# Women's 2012 Softball League

It's time to enroll in the Women's Softball League. Whether you are an avid softball player, or just out for the exercise, there is a team that will fit your skill level. So join the fun and get ready to take the field!

All SFEA members (including non-employee spouses and dependents 17 years old and out of high school) are eligible to participate in this league. Teams must consist of at least 10 full time players.

## **Divisions:** Recreational & Competitive

Sub Pool! If you are interested in playing but cannot commit to a team, the sub pool is for you. For the \$6 sub fee, you can have your name put on a call list in the event a team is going to be short players for an evening. The sub list will be made available to the captains in each division. You cannot be in the sub pool if you are already a dedicated sub for a team.

The league runs from May - August. All games will be played at State Farm Park. The league is governed by ASA Softball Slow Pitch rules. Competitive league games will be on Tuesday nights, Recreational league games will be on Wednesday nights.

\*Rainout games will be held on Mondays at 5:30 p.m. & 6:30 p.m.\*

**New this year:** In an effort to avoid forfeits, players may sign up to play in both leagues. However, a Recreational team may not have more than three Competitive league players on its roster. Players may only enroll with one team per league.

**Enrollment closes on March 7 (add close date to my calendar).** The enrollment fee is \$12 per full-time player (a minimum of 10 full-time players are required) and \$6 per substitute player. Players may sign up as subs, but will not be eligible for awards. SFEA members who wish to play but are not associated with a team, are encouraged to sign-up as individuals. Each individual participant will be assigned to an existing team with an open roster or combined to form a new team.
