<u>Age Groups For 5K Race</u>	
All Participants in the 5K Walk/Run will be broken down by men and women into the following age divisions:	
19 & under	35-39 years
20-24 years	40-44 years
25-29 years	45-49 years
30-34 years	50 and above

<u>Age Groups For 1 Mile Race</u>	
All Participants in the 1 Mile Run will be broken down by girls and boys into the following age divisions:	
8 & under	13-14 years
9-10 years	*15 & over
11-12 years	*no awards for this age group

To see the race courses, please visit the SFEA Sports League Intranet page on the SFEA website. Prizes will be awarded to 1st and 2nd place overall male/female winners and the top three in each age division. All participants will receive a technical shirt. Please indicate size of t-shirt needed on the enrollment form. Post-race goodies and beverages will also be available.

Children ages 1-12 can run in a 1/4 mile Children's Fun Run. Parents are encouraged to run with their children. All children will also receive an award for participating. *If your child signs up for the 1 Mile Race, they may compete in the Fun Run for free, but will not receive a second shirt.* An SFEA member may enroll any or all dependent family members listed on their membership.

Walkers are welcome to participate in either the 5K or 1 mile event.

You must register before 1pm on May 15 to receive a shirt. Although registrations will be accepted by the office after the shirt deadline, they will not receive a shirt. **There will be NO registration on the day of the event.** A waiver needs to be submitted for each participant. **Race packet pick up will be available prior to the race.** Make checks payable to SFEA. All enrollment forms and money must be received in the Corporate South Activities Office, K-1, to receive your race bib. The Activities Office is not responsible for cash sent through the mail or late delivery of the mail.
