



# Adult Summer Co-Rec Volleyball League

It's Adult Co-Rec Volleyball time again! Are you ready? The season runs from June-August, and all games will be played at State Farm Park. Games will be played on Wednesdays. Game times are 5:15, 6:15, 7:15 and 8:15 p.m.

**Rainout games will be held on Thursday of the following week for all leagues.**

**Enrollment closes on Thursday, May 17.** Enrollment fee is \$17 per player. **One check per team is required.** Make checks payable to SFEA. All completed enrollment forms with appropriate fees must be received in the

## **Enrollment Guidelines:**

- Any SFEA member may enroll any or all dependent family members of at least high school age and listed on their membership. Teams must consist of at least 8 players. Each player must complete the attached waiver and submit with the team registration. (For a team of 10 players, please submit 1 registration form, 1 check, and 10 waivers) Leagues are open to SFEA members only. A minimum of 4 teams must enroll to hold the league. If the minimum is not met, enrollment fees will be refunded.
- Participants may enroll in only one SFEA Adult Summer Hard court Co-Rec volleyball team.
- A team must have a minimum of 4 players on the court at all times. A team must have at least 2 females and 1 male on the court.
  - **EXCEPTION:** During the regular season, a team may play with 1 female as long as there are 3 males to meet the minimum required 4 players. Teams playing with one female can only play 3 or 4 males in this instance. This exception should only be used to avoid a forfeit.

The league will be governed by State Farm recreational regulations and by the USAV rules and regulations, except as noted in the published league rules.

Teams must consist of a minimum of 8 players. Rosters that are submitted with less than 8 players will have individual enrollees, if available, added to their rosters to bring them to the minimum roster requirement. If enough individuals are not available, rosters with less than 8 players will have the option of having its members converted to individual enrollees or have their money refunded.

Individuals are encouraged to sign up even without a team. New teams will be formed if enough individuals sign up to play or individuals may be placed on existing teams.
