



2018 SFEA Men's Golf Event



4-Man Best Position Tournament

WHEN: Monday, May 21st. Choose between 8 am and 1 pm shotgun starts (sign up closes May 10th)

WHERE: Crestwicke Country Club, www.crestwicke.com

COST: \$45 per person – This includes 18 hole green fee with cart and range balls. Payable at time of entry. Please make one check for the team, payable to SFEA.

AWARDS: The top 3 net team scores, longest putt (front and back), longest drive (in the fairway - front and back), & closest to the pin (all 4 par 3's). Each person may win a maximum of 1 team and one individual prize (awarded based on lowest hole number of skill hole won). Any high school students and college athletes may play but are not eligible for any awards.

TEAMS: Limited to members of the SFEA Men's golf association:

- Must be a SFEA member to play.
- Must be a member of SFEA Men's golf association (if you are not a member, you can sign up on this form to play events only for (\$5) and include a signed waiver (page 3).

FORMAT: SFEA Men's golf league rules apply with the following exceptions:

- The ball is played up everywhere including bunkers and hazards.
- The ball cannot be moved from one area to another (e.g. Rough to Fairway, out of a hazard or bunker).
- The ball must be placed within a one foot length, no closer to the hole and in like conditions, except on the greens. The ball should be placed in relatively the same position.
- The scramble will be played from the Blue tees.

HANDICAPS: Handicaps will be calculated using 2018 SFEA Men's golf association handicaps as of May 14th. If you do not have a 2018 handicap, please provide your USGA handicap (if have one) and if not, then your average score on the front 9 of Prairie Vista (and will determine handicap based on league rules).

Team handicap will be determined by taking the sum of the 4 player's 9-hole handicap and dividing by 3.75 (if USGA handicap is provide, will divide by 2 to get 9-hole handicap). If less than 4 players, will be given a ghost player(s) with a league handicap of 6.

- First name listed denotes team captain. **Also send an email to Dan Fischer (liq3) with team info.**
- USGA Handicap only needed if didn't play in men's league in 2017. PV Front 9 score only needed if didn't play in men's league in 2017 and do not have a USGA Handicap.
- Please also include an email address if not a State Farm employee.
- Check if new SFEA Men's Golf Association member (have not paid league entry fee through league or prior event). If new, please include an additional \$5 for each new member made payable to SFEA.
- Include one check per team \$45* per player plus the \$5 for each person that is not on a 2018 roster and has not already paid the \$5 events only league fee for 2017 or a guest for the event.
- Please indicate start time in numeric order (1 for 1st choice, 2 for 2nd choice). If could only do one time, then just mark that time with a 1. If flexible and can play either time, put an X by no preference.
- Although we can accommodate many teams, there are a limited amount of spaces available. These will be filled on a first come basis based on time preference.
- Check if a player is either in High School or a collegiate athlete.

Double Play Option

We will allow for play in both the 8 am and 1 pm start times if space is available.

- The fee for 2nd round is \$20. If second entry, adjust entry fee accordingly.
- If you wish to play both times, please fill out two separate forms and mail in two separate checks.
- The \$20 is at an individual level.
- You may play with the same or different partners in morning and afternoon rounds.
- Each person can only win one team award (example: Mike plays with John and team gets 1st net, and also plays with Bob and team gets 2nd net, Mike will win prize for 1st net, John for 1st net, and Bob for 2nd net).
- If submitting second entry for a person, please write "Yes" by Double Play Entry. Otherwise "No".
- We will first fill the available 1 pm time slots with players playing 1st round, then fill in any remaining slots with those wishing to do the Double Play.

Individual Signups/Teams short players

We will accept individual signups or teams with less than 4 players. We will attempt to form complete teams. If we can't match individuals up with a team to play with, your entry fee will be returned. Any team short players must be willing to accept individual players.

- Same costs as above apply for individuals or teams short players
- Fill out the first line(s) of the entry form

If you are a new member to golf league, you must include the following release form in your entry. Those that have already sent in a waiver for a 2018 sports league/event need not resubmit. Thank you!
