Eligible to Join

Any SFEA member may enroll any or all dependent family members of at least high school age and listed on their membership. High school participants and collegiate athletes are not eligible for awards. Leagues are open to SFEA members only.

Each player must:

- Complete the attached waiver and submit with the team registration.
- For a team of 10 players, please submit 1 registration form, 1 check, and 10 waivers

League Format

- Team Competitions
- Weekly 4 on 4 matches – 4 players from each team participate each week
- Stroke Play – With Handicaps
- Weekly Low net awards
- Team Awards for first and second half of season and final end of season winners
- Each player competes for individual and team points
- Our League is governed by SFEA Men's Golf Association rules and bylaws
- Rules and bylaws are available on the SFEA Men's Golf Website
- \$10 Entry Fee per player (you also pay greens fees each time you play)
- Eligible for 4 tournaments with awards–Event postings/ dates to be placed on SFEA site
- League matches will be played from the week of April 30th through August

Enrollment

- Returning Team Captains: Fill out enrollment forms (attached) – one per team
 - Send completed team forms to Corporate South Employee Activities Office (K-1) by **Thursday, March 29th** - Send one check per team - payable to "SFEA" along with waiver form for each player on the team.
- New players and Captains – New Captains and Players are welcome
 - We will accept individual sign ups and will organize new teams (where a player volunteers to be a Captain of a new team) or we'll add you to existing teams. Send checks - payable to "SFEA" with your individual sign up forms & waiver.
 - Or sign up as a new team (same process as returning teams)
- Players may also play in Events Only (no league play) for \$5 entry. Please sign up using individual entry only for event only option.
