Come celebrate an evening of fun at the Children's Discovery Museum while it's closed to the public and open only for our SFEA event! Come for the exhibits, make special Easter crafts, play games, and bring your own camera to take pictures --- with or without the Easter bunny, who will be hopping around the museum!

The enrollment fee is \$10 and applies to everyone age two years old and up. Museum membership cards **will not** be honored for this event. The \$10 fee includes entrance to the museum, crafts, and activities. **Children must be accompanied by an adult SFEA member to attend this event.**

NEW this year: For those interested in having dinner at the museum, you may order an Avanti's meal for \$5 that includes 1/3 gondola, bag of chips, cookies, and a juice box **(additional to the member ticket fee).**

An employee SFEA member may bring any or all dependent family members (listed on their membership) at the member price **AND** one guest at the **member price of \$10**. Violation of membership privileges (signing up those NOT on your membership) could lead to your SFEA membership being revoked. If you are unsure of your membership benefits or who is included as a member, please contact the SFEA office.

Enrollment for this event closes **Tuesday, February 26** and we must have 200 enrolled attendees at the close date in order to proceed with the event. If the demand exceeds available capacity (500), a drawing will be conducted. All completed enrollment forms and payment will need to be received by the HRSS/Activities Office to be eligible for the drawing. **If you are enrolling with a friend and wish to be considered as one group for the drawing, please staple your enrollments together and mail in one envelope.** Please make checks payable to SFEA. The Activities office is not responsible for cash sent through the mail or late delivery of mail.

Please contact the Activities Office if you need to cancel your enrollment. If there is a waiting list and your ticket is resold, your money will be reimbursed. **If there is not a waiting list, your money will not be reimbursed.** In order to maintain records and a degree of fairness, do not sell your ticket to co-workers. The Activities Staff will handle all transactions.
