



# Parent/Child Painting Class

When: Saturday, October 19<sup>th</sup>: 10 am-12 pm & 1 pm-3 pm  
(Recommended for ages 5 & older)

Location: Merlot & A Masterpiece, 411 N. Main Street, Bloomington

Participants will create a unique piece of art with guidance from professional artists. This painting might be difficult for children in a younger age range, so this event is recommended for children 5 years or older. This is not a drop-off event. **Parents will need to enroll with their child/children and stay with them for the duration of the event.** The enrollment fee for each participant is \$10.00.

The studio will provide the canvas, easel, brushes, paints, and aprons. Acrylic paints will be used and will not come out of clothing, so appropriate attire is recommended! No snacks or drinks will be provided for this event, but you may bring a bottle of water if desired.

An employee SFEA member may bring any or all dependent family members listed on his or her membership OR one guest. Violation of membership privileges (signing up those NOT on your membership) could lead to your SFEA membership being revoked.

All enrollment forms and checks must be received in HRSS/ Corporate Activities, A-1, no later than **October 1st**. Mail to HRSS/Activities, A-1 Corporate, or employees may use the drop off mailbox inside the entrance to Human Resources (A-1) from the Atrium. Make checks payable to SFEA; cash will not be accepted. If you would like to participate with other specific members, please staple forms together and mail in one envelope.

Once selected to attend the event, we are unable to provide a refund. In the event that demand exceeds available capacity, a drawing will be conducted. Should the event go to a h, those not selected will be notified by email, and their checks and enrollment forms will be confidentially shredded.
